GIVE BRIEF DESCRIPTION OF WHAT HAPPENED:

On January 6, 2026, Commander Bagshaw with the Metropolitan Police Department was working multiple First Amendment demonstrations occurring on the National Mall in the area of 3rd and Constitution Ave, NW, in Washington, DC. Commander Bagshaw was on duty and in full uniform with police identifiers displayed when he was approached by the suspect, Edward Jacob Lang. Suspect Lang approached Commander Bagshaw and began to confront him about events that occurred on January 6, 2021, at the US Capitol.

Suspect Lang directed threats to Commander Bagshaw, which were witnessed by other members of the Metropolitan Police Department. They were also posted by way of a video recording on Instagram. Below are the statements that were threatening and directed towards Commander Bagshaw:

"A Pitbull that needs to be put down."

"And hung right here in front of the capital on National TV, we would love to see that."

"Deserve to be put down like a dead dog."

"Public execution is the only solution for animals like you."

"Your day will come, and I will be there for it, look left and right when you cross the street motherfucker."

"We need to do more, drag him out by his ankles and throw him in the Potomac."

"He will get his."

During the confrontation, Suspect Lang made it clear he was referring to Commander Bagshaw by pointing at him and calling him by name. The confrontation continued, and Commander Bagshaw tried to walk away from the situation; however, Suspect Lang continued to follow the Commander and other members for several minutes. Lieutenant J. Mendez was one such member and witnessed the threats.

Lieutenant J. Mendez told your Affiant that he is familiar with Suspect Lang as he has monitored many demonstrations with Suspect Lang in attendance, including during another demonstration the day prior. Lieutenant J. Mendez advised that the suspect's name is Jake Lang.

Your affiant queried law enforcement indices and determined that Suspect Lang's true name is Edward Jacob Lang with a date of birth of April 7, 1995 and goes by "Jake Lang." Lieutenant Mendez confirmed that Edward Lang and Jake Lang was the same individual, and your affiant reviewed the January 6, 2026, video to recent photographs of Edward Lang and confirmed it was the same individual.

As a result of your Affiant's investigation, your Affiant respectfully requests that an arrest warrant be issued for Edward Jacob "Jake" Lang, Date of birth: April 7, 1995, PDID: None found, of [REDACTED] Florida 33467.
